NBLC Gem & Jewellery Festival 2023 - Conditions of Trading- Indoor Stalls -

- 1. Gates will be open from 6.00am on Saturday 14th October for setting up. The show commences at 8.30am to 4.30pm.
- 2. Setup time in the Virgina Football United Club Rooms will commence from **4pm Friday** or **6am Saturday** morning. Prior to these times NBLC will need unrestricted access to set up tables and electrical cables.
- 3. All traders will need to exit the building by 6pm Saturday. No smoking allowed on the premises. This will be strictly enforced.
- 4. Goods for sale should be
 - a. Rock/Stone/Gem/Lapidary/Lapidary Craft Materials/Lapidary Machinery and Tools or Lapidary books.
 - b. Jewellery can be sold if it is designed and made in Australia or designed in Australia and manufactured overseas as one-off. No mass produced jewellery is to be sold;
 - c. Second hand goods to be offered for sale should be in the sale line (Gem / Lapidary).
 - d. Stallholders may be asked to remove goods that do not comply.
- 5. No raffles or auctions are to be conducted.
- 6. No items not included in the listing under point 4 are to be sold unless with permission by the show convenor or sold by North Brisbane Lapidary Club (food, drinks and raffle tickets).
- 7. No trader may invite another party to trade at the Gem and Jewellery Festival of the NBLC.
- 8. Electrical leads in use have to be tested and tagged in accordance with the electrical Safety Act (2002).
- 9. All material for sale should be correctly labelled. Treated stones and synthetic, simulant material or lab created material is required to be labelled as such.
- 10. In the event of a dispute, between a stall holder and a purchaser, over the authenticity or accuracy of labelled materials a full refund will be made by the seller to the purchaser.
- 11. Where material is identified, by a qualified person, as being incorrectly labelled or described, the material will be removed from sale until correctly described. Failure to remove incorrectly identified material will result in the stall holder being removed from the event.
- 12. A public liability insurance policy in the amount of \$20,000,000 is required to be held by each trader. The policy is to be in the name of the stall holder or the stall holder's business trading name. If evidence of a current policy is not provided prior to the event, the trader will be excluded.
- 13. Traders are responsible for their own insurance to protect against theft, loss or accidental damage.
- 14. FREE parking is available in the grounds.

- 15. If a trader cancels their booking within 7 days of the event, and the site cannot be resold, the site fees will be forfeited. If the site is resold a full refund will be made. Cancellations more than 7 days before the event will receive a refund of site fees already paid less \$25 administration fee.
